Dear 8th Grade Parents,

The Northwestern Band, Chorus and Orchestra have been selected by Disney Performing Arts to be part of the entertainment at the Walt Disney World Resort! We will travel to Orlando, Florida from **Friday, March 10th** to **Tuesday, March 14th**, **2023.** We would like to assure you that your child's safety while traveling is our first concern. We have had a great deal of experience with performing groups on overnight trips. There will be Fulton County certified chaperones monitoring the students. The Disney parks are very safe for teenagers; there will be open cell phone communication between directors, students, and chaperones while we are in the parks and students are never left unsupervised in the hotel. Students will be required to abide by all Northwestern and Fulton County policies on this trip including use of language, personal displays of affection, and the dress code. Likewise, we will also follow all COVID mitigation protocols that are in place at the time of the trip for Fulton County Schools, Northwestern MS, and the Disney theme parks.

The behavior expectations will be reviewed extensively with students before the trip and a contract will be published with the other trip documents. Students who do not abide by the rules or who are late to meeting points while traveling will lose time in the parks and/or will receive the same disciplinary consequences as if we were in school. To keep our trip supervision closely monitored, students who travel with us are required to stay with our group exclusively, and with their assigned chaperone. For student safety, students on our trip may not spend time with parents or other friends/relatives while we are in Florida, either in the hotel or in the parks.

If your child has motion sickness, acrophobia, agoraphobia, claustrophobia, fear of loud noise (fireworks), panic attacks, or may be in any way unable to participate in theme parks, please consider becoming a chaperone for your child for this trip and contact your child's director BEFORE signing up for the trip. We want everyone to be able to enjoy their Disney experience.

Additionally, all eighth-grade students are required to meet the behavior and participation guidelines listed below in order to participate in the trip. We will be in continual communication with parents regarding any student who is not meeting these expectations. If you have questions about these expectations, please talk with your director.

Daily Participation- All students must meet the daily behavior, participation, practice, and performance expectations in their music class and throughout their school day. Students must be in good standing with all of their teachers to travel to Disney with their music class. Parents will be notified and students who do not meet the minimum expectations will not be invited to travel.

Performance Attendance- Music classes are performing ensembles, and as such, regular attendance at rehearsals, clinics, and concerts is a necessity to ensure a quality, rewarding musical experience. The invitation to perform at Walt Disney World is a privilege and is considered a reward for the students' continued commitment to the music class. Students are expected to attend all extra-curricular rehearsals, performance evaluations, clinics, and concerts throughout the year. Please refer to your student's performance calendar and syllabus for guidelines for excused/unexcused absences. Unexcused absences from performances or workshops can result in your child not being able to attend the trip.

Behavior- Students who earn school suspension (ISS or OSS) may not be allowed to travel. Students who have displayed a pattern of misconduct, had a major infraction(s), and/or have been suspended from school may lose the privilege to attend the trip. The principal and assistant principal will have the final decision about student participation in any school field trip.

School Attendance- Students may not have chronic unexcused absences from school.

Grades- Students must maintain an A in their music class and pass all their other classes to travel.

Refunds- No refunds will be given according to the policy determined by Creative Group Tours.

We will leave after lunch on Friday, March 10, 2023. Students must bring luggage to their music classroom early on Friday morning before school, complete the performance uniform check, be on time to first period and attend classes through lunch. We will return to NMS on Tuesday, March 14, 2023 in the late afternoon or evening. Monday, March 13th and Tuesday, March 14th, 2023 are holidays for students. The complete trip itinerary will be finalized and published after we receive our times from Disney Performing Arts. This year, our performance will NOT be open to the public.

The cost for the trip will be between \$890.00 and \$965.00 per student, depending on how many people participate. The range in cost is due to the fixed cost of the bus, no matter how many people ride on each bus. The first NON-REFUNDABLE payment is \$500.00 and is due by Friday, December 2 at 4:05 pm. The exact amount of the final payment will be determined after we have commitments from everyone who is traveling- it will be between \$390 and \$465. The cost of the trip includes transportation on a charter bus equipped with a bathroom and televisions with DVD, four nights lodging, three days admission to Disney World parks, three \$25 Disney meal cards, and a breakfast buffet for four mornings. Students will need some spending money for souvenirs and additional meals. Students will be housed four to a room in the hotel.

Roommates will be chosen by students as soon as the trip deposit deadline passes. It is the student's responsibility to share their roommates' names with their parents. Please discuss roommate decisions with your child prior to committing to the trip as we will be unable to change student rooms once the trip roster is finalized.

Our tour company, Creative Group Tours, will handle the payments. Log in to https://CGTPay.com using the account number «Participant_ID» and pin number «Participant_PIN» and make your deposit payment of \$500. Please pay exactly \$500 to keep our bookkeeping straightforward and simple. Please note this is a unique login for «First Name» and is not interchangeable with other students (even siblings). The deposit payment deadline and paperwork deadline is FIRM. We will assume that students who do not pay the deposit or return the forms are not planning to travel. The entire packet must be submitted to your director by the deadline of Friday, December 2 at 4:05 pm. The final student payment amount will be published as soon as possible and will be due in early January.

We will have a mandatory parent meeting (please, no students or other children) on **Tuesday**, **February** 7^{th} **from 6-7 p.m**. to go over the details of the trip including the required paperwork. We will have a notary available that evening to notarize your medical forms, as well as a Spanish translator. Be sure to bring your health insurance card.

Please return THE OTHER COPY OF THE PACKET with the student name and parent initials or signature on each page by Friday, December 2 at 4:05 pm if your son or daughter will attend this trip. We look forward to traveling and performing with your child. Please do not hesitate to contact your director at any time if you have questions.
